

As an insight, the Aluminum Smelter Company of Nigeria, ALSCON, which was set up with \$3.2 billion, was sold to a Russian firm, Russal, for a paltry \$130million. Delta Steel, which was set up in 2005, at a cost of \$1.5billion, was sold to Global Infrastructure for just \$30million.

ALSCON got back \$120million for the dredging of the Imo River, which was never carried out.

Three, which is linked to the one above is the growing profile of President Buhari as the Champion of Democracy not only at home and in the West African subregion but the African continent as whole.

President, Obasanjo destabilized internal democracy by orchestrating impeachment after impeachment of governors

who were not compliant with his highly imperial administration.

As we said sometime back, Mr. Obasanjo's tenure, 1999-2007, represented the dark days of Nigeria's democracy due to a slew of assaults on the constitution.

The former president deployed federal machinery to remove governors Joshua Dariye, Rashidi Ladoja, Peter Obi, Chris Ngige and Ayo Fayose from office.

They were the then governors of Plateau, Oyo, Anambra, Anambra and Ekiti, respectively, unjustly removed using the police and secret service under his control.

Under him, a five-man legislature met at 6:00 am and "impeached" Governor Dariye in Plateau; 18 members out of 32 removed Governor Ladoja of Oyo from office; in Anambra, APGA's Governor Obi was equally impeached at 5:00 a.m. by members who did not meet the two-thirds required by the constitution.

Lawmaking powers of the Rivers State legislature were transferred to the federal parliament to punish Governor Amaechi for shifting his political alliance.

Moreover, he damned the Media & Publicity Supreme Court and unlawfully

held back Lagos State revenues due from federal sources on account of his pettiness against Governor Bola Tinubu.

On the other hand, in Washington a few weeks ago, the US President Joe Biden at a meeting with African Heads of States and Government described President Buhari as a champion of democracy and role model for the leaders of African states.

Clearly, Obasanjo has become even more jealous by adopting a vengeful attitude.

Four, to say that "frying pan to fire" is the situation in Nigeria at this time should be read to mean a personal experience to him and we know what that means.

"Hell" for Obasanjo is when a President, any President that comes after him refuses to be his own puppet, to do as he wishes on all matters and at all times.

He then keeps attacking out of frustration. Obasanjo's vengeful attitude towards President Buhari is the height of selfishness and little short of moral squalor.

he Peoples Democratic Party (PDP) and the All Progressives Congress (APC) have countered the views of former President Olusegun Obasanjo, following his endorsement of the Labour Party (LP) presidential candidate, Peter Obi, in the forthcoming election.

This comes hours after Obasanjo, on New Year's Day, in a six-page open letter addressed to the Nigerian youth in particular, described Obi as his mentee, saying the former Anambra State governor has an edge in the February 25 election.

"One other important point to make about Peter is that he is a needle with thread attached to it from North and South and he may not get lost," the former president wrote.

"In other words, he has people who can pull his ears, if and when necessary. He has a young and able running mate with a clean track record of achievement both in public and private life."

However, a member of the Strategic Communications Directorate of the PDP Presidential Campaign Council (PCC), Anthony Ehilebo; and a spokesman for the Tinubu/Shettima PCC, Kehinde Bamgbetan criticised the endorsement on Monday when they appeared on Channels Television's Sunrise Daily.

"I have a very strong opposition to anybody who would seem to want to control the president of Nigeria either by a thread or a needle or by pulling his ears," Ehilebo said. "We want an independent president. We want a president that can take decisions and own his time in government.

"It reminds us of what happened prior to 2015 when he also wrote a letter to instigate Nigerians to change Jonathan because he felt he was no longer in control of Jonathan."

The PDP chieftain likened Obasanjo's message to the 18-page letter he wrote in 2013 and addressed to then President Goodluck Jonathan, in which he told his successor to "forget about 2015."

"Werememberthathewrotethese letters against then President Goodluck Ebele Jonathan and he's now complaining seven and a half years later that we are going from frying pan to fire.

"I would suggest that somebody that put us in a frying pan will sit this one out and allow the Nigerians to make a choice, instead of foisting a subjective opinion on Nigerians," he said.

In a similar vein, Bamgbetan argued that any "self-respecting" presidential candidate in Obi's shoes would not be proud to continue campaigning after Obasanjo's comments.

"For somebody to tell you that you are a needle who must have a thread, you are somebody who he will be pulling your ears, those are very deprecating (words) for somebody to put a president in place.

"Much of what he said on that

occasion, if you look at it very well, they don't even give Mr Peter Obi any modicum of respect. The manner in which he described Mr Peter Obi, if we were in his shoes, would not be something we would take to the bank. We don't even think that was fair to the man," he said.

Responding to the criticisms, the Chief Spokesperson, LP PCC, Yunusa Tanko stated that as a former president, Obasanjo is equipped to know and assess "virtually everybody" he has had dealings with.

"Even at a distance, he can easily measure you with your capacity and your strength and what you have done over the years. He looked at the track record of Obi in Anambra State in a micro situation. "In terms of security, he scored. In terms of infrastructure, he scored high. In terms of accountability, he scored high. In terms of compassion to the people, he scored high – from his own assessment as a former leader which he used as a yardstick," he said.

The Spokesperson and Director, Public Affairs of the Atiku Abubakar/Ifeanyi Okowa Presidential Campaign, Senator Dino Melaye, Monday reacted to the endorsement of the Presidential candidate of the Labour party, LP, Peter Obi, by former President Olusegun Obasanjo.

Dino in a statement he made public on his Twitter handle, mocked the former president's endorsement of Obi. He noted that Obasanjo will attend council of state meeting with Atiku as president.

But reacting today, Dino opined: "God will keep Obasanjo alive, and he will attend council of state meetings with Atiku Abubakar as President and Commander In Chief Of The Armed Forces Of The Federal Republic Of Nigeria. I also want to assure him that his honorarium will be paid".

Reno Omokri, a former aide to ex-President Goodluck Jonathan and staunch supporter of the presidential candidate of the Peoples Democratic Party, Atiku Abubakar, has said that former President Olusegun Obasanjo has always wanted a president from the South-East.

Weighing in on the former president's endorsement of the Labour Party presidential candidate, Peter Obi as his choice candidate for president, Omokri on Sunday night, took to his Twitter page to express his opinion on the matter.

he Special Adviser, Media and Publicity to President Muhammadu Buhari, Femi Adesina has reacted to the statement credited to the Bishop of Kaduna diocese, Hassan Kukah. Kukah had in his Christmas message accused Buhari's administration of nepotism, noting that Buhari has failed in fulfilling his campaign promises to Nigerians

He said the broken promises of Buhari are leaving Nigerians more vulnerable, adding that the corruption he promised to fight has become a leviathan and sadly, a consequence of a government marked by nepotism.

But reacting to the above statement in his article titled: 'Kukah don't cook me nonsense', the presidential spokesperson averred that if Kukah was succeeding in his duty as a priest, then his adherents should be less prone to corruption, and the leviathan should have been slain, or badly wounded.

Two Senegal Lawmakers Jailed Six-month For Hitting Colleague

MPs were handed sixmonth jail terms on Monday for physically attacking a female colleague in parliament.

In a case that sparked anguished debate about democracy in Senegal, pro-government legislator Amy Ndiaye was slapped and then kicked in the belly during a chaotic session in the National Assembly.

MPs Mamadou Niang and Massata Samb were each given six-month prison terms after a trial that began on December 19.

They were also each fined 100,000

ordered to pay five million francs in damages. Prosecutors had sought two-year terms.

The bust up happened on December 1, during a routine vote on the justice ministry's budget.

It was sparked by remarks Ndiaye had made about Serigne Moustapha Sy, an influential Muslim leader who supports the opposition but is not a lawmaker.

After order was restored, Ndiaye fainted and was given hospital treatment — her lawyer Baboucar Cisse said she was pregnant and

baby.

She has since left hospital but "remains in an extremely difficult situation," Cisse said.

The incident triggered a fierce debate about parliamentary discourse and attacks on women. It notably coincided with an awareness campaign against domestic violence.

Pipeline Surveillance: Ex-militant group asks FG to review OML 30, OML 34 contracts

n ex-militant group, Isourhobo Bombers, has issued a sevenday ultimatum to the Federal Government of Nigeria to address what it described as a discriminative security surveillance contract awarded some individuals without recourse to ex-militants in Isoko and Urhobo lands to wit: OML 30 and OML 34.

The group led by ex-agitator, Major General Titus Deadman made this known in a statement sent to Vanguard, adding that, the FG has deceived the youths of Niger Delta region for too long and that the time has come for them to take their destiny in their hands.

General Deadman urged the Federal Government to within seven days of his statement, award them the



contract for the security of pipeline surveillance in their respective domains, maintaining "the current contract award is discriminatory and totally unacceptable to ex-militants of Isoko and Urhobo extractions."

"Also, the FG must end gas flaring in both Isoko and Urhobo lands, a development," he noted, "No longer obtains in developed climes but that government in Nigeria have persistently paid lip service to ending what he described as dangerous

According to him, "An ex-militant leader, who was sent to deceive them to stop the Niger Avengers in 2016 is on their wanted list of the group for allowing himself to be used by the FG to deceive the youths of the two nationalities."

Deadman said, "All oil exploration activities in Isoko and Urhobo would be disrupted should the government fail to heed this call.

"Don't push us back to the trenches again. Our sympathy goes to those oil workers, who may choose the path of defiance to this ultimatum. Withdraw this surveillance contract and reaward it evenly. To be forewarned is to be armed," Deadman stated.

Missing UK-based Nigerian found dead after four weeks

United Kingdom-based Nigerian, Taiwo Balogun, 53, who went missing on Thursday, December 1, 2022, has been found dead in a lake in Kent. Balogun from Crayford was last seen near her home in southeast London four weeks ago.

Her body was found in a lake at Bluewater shopping centre in hunt for "vulnerable" missing mother who vanished four weeks ago from home in London, a report by Daily Mail UK said. The Met Police, on Monday, said a woman's body had been found in a lake in Kent, adding that her death was not being treated as suspicious even though it was unexpected.

The force tweeted: "A woman's body was recovered from a lake near Bluewater Shopping Centre on Friday, December 30. While formal identification awaits, Taiwo Balogun's family has been informed.

"Her death is being treated as unexpected but not suspicious. Our thoughts are with Taiwo's family."

Footage from a CCTV camera showed Balogun at the Lottery stand inside a shop on Crayford Road, Dartford, at around 2:27pm on the day she went missing. In a previous statement, Balogun's family said: "We are very worried about our mum. She is greatly loved and a massive part of our lives."

2023: Obasanjo's endorsement Obi worthless- Onanuga

Bayo Onanuga, Director, Media and Publicity, All Progressives Congress (APC) Presidential Campaign Council says the endorsement of Peter Obi, by former President Olusegun Obasanjo, is worthless.

Onanuga said this in a statement in Abuja.

"We read with amusement the endorsement of Mr Peter Obi, the Labour Party presidential candidate by former President Olusegun Obasanjo in his New Year message on Sunday.

"Following calls by journalists from various media houses who asked for our reaction, we decided to make this preliminary statement, though we didn't consider the socalled endorsement to be of any value.

"Any discerning political watcher in Nigeria knows that Chief Obasanjo's preference for Peter Obi is expected,"he said.

This, he said, was especially because Obasanjo had earlier stated his position in various public events, the last being at the 70th birthday of Chief John Nwodo, a former President of Ohaneze Ndigbo in Enugu.

Onanuga said that Asiwaju Bola Tinubu, the APC 2023 presidential candidate would not lose sleep over Obasanjo's endorsement because he was notorious for always opposing progressive political forces.

He said that the former president did same against MKO Abiola in 1993 presidential election.

"The endorsement is actually worthless because the former president does not possess any political goodwill or leverage anywhere in Nigeria to make anyone win a councillorship election.

"Let alone win a presidential election, he is a political paperweight, he is also not a democrat anyone should be proud to be associated with," Onanuga said.

NIS recue 6 human trafficking victims in Jigawa

he Nigeria Immigration Service (NIS), Jigawa Command, said it rescued six victims of human trafficking in the state.

The NIS Comptroller in the state, Mr Ahmed Bagari, told newsmen in Dutse on Monday that the victims were rescued by men of the command on Sunday.

Bagari, represented by DCI Muhammad Yako, said the victims were rescued at about 6:30 p.m. in an uncompleted building in Babura town, headquarters of Babura Local Government Area of the state.

He explained that the victims, aged between 20 and 35, were intercepted while on their way to Libya en route Niger Republic.

The comptroller added that the victims, five females and a male are from Oyo and Nassarawa states.

According to him, none of the rescued victims was in possession of any

travel document and no incriminating items were found on them during interrogation.

"The victims were rescued on Sunday, the 1st January, 2023 on their way to Niger Republic en route Libya.

"The victims are made up of five females and one male that hailed from Oyo state; only one of them is from Nasarawa State.

The victims are as follows: Olalekan A. Alabi, aged 35; Kehinde adetunde, 26; Afolabi ajibola, 24; Adedoyin Adetoji, 20; Olawuyi Mose bolatimoyo, 35 and Blessing John, 22.

"The victims were rescued in an uncompleted building in Babura town which we believe they were kept by a syndicate," the comptroller said.

He added that the NIS Comptroller-General, Mr Idris Jere, had directed that the victims be handed over to the National Agency for Prohibition of Trafficking in Persons (NAPTIP) for further action.

UlTH assault: We record attacks every week – NMA

he Nigeria Medical Association (NMA), Kwara Chapter, has said that it recorded physical or verbal attacks on its members almost every week.

Dr Ola Ahmed, the state NMA Chairman, made this known to newsmen on Monday in Ilorin.

Ahmed lamented that medical doctors in public healthcare facilities across the state and the University of Ilorin Teaching Hospital (UITH) are being attacked for no cogent reason.

"Attacks on our members have been recorded across different hospitals in the state.

"Several reports, engagement and letters have been written to our employees, especially the management of UITH and Kwara Government, but we have not seen remarkable improvement," he said.

Ahmed revealed that the series of assault is causing psychological trauma for their members as they fear for their lives.

He cited the recent attack on a member of the Association of Resident Doctors, ARD-UITH, by some relatives of a deceased patient.

He also decried the alleged killing of a medical doctor by patient's relative in Delta while rendering services, adding that the Kwara NMA will not wait until that happens in the state.

The chairman however observed that 2022 was a very tough year for all Nigerians due to the economic hardship, as occassioned by high inflation, high cost of goods and services.

He also cited the devastating flood that ravaged many states, including Kwara, and later compounded by high cost petroleum products.

Ahmed stated that the healthcare system was also affected, while observing the poor remuneration, unencouraging condition of service for doctors in the country and inadequate infrastructure to perform duties.

"Many of our colleagues have left the country and the state and many more are ready to leave due to poor working conditions.

"The few of us left are struggling to cope with the difficult working environment, the ever-increasing patient load and at the same time take care of our families," he said

Ahmed thetefore appealed for understanding and patience from people, in following due process in expressing their grievances, adding that doctors will give care with respect and dignity to all.



What's the worth of Obasanjo's endorsement?

President ormer Obasanjo Olusegun used to be a chimera. His influence was mythical yet sweeping. In the past, Nigeria was too small to contain his stature — as he dominated the horizons across Africa and beyond. He lived up to his legend of being a human Orisa. He is, perhaps, still one of the most respected leaders out of Africa.

But Obasanjo's influence within Nigeria appears to have ebbed over the years. His words seem to have lost lustre and his presence vacant of command. Perhaps, when a masquerade comes out to perform all the time, and sometimes without an invitation, it loses its allure and charm.

From 2007 (after he left office) up until 2014, Obasanjo had his wonder and thunder. His position on national matters mattered and was sought after.

His missives were denominated "letter bombs" for their sheer quality to inflict maximum casualty on the target and sway public opinion.

In 2013, former President Goodluck Jonathan suffered "casualty" from one of Obasanjo's

missives. Obasanjo wrote an open letter which technically put a nail to the re-election bid of Jonathan.

In the letter titled "Before it is too late", Obasanjo accused Jonathan of many malfeasances. He said: "Allegation of keeping over 1000 people on political watch list rather than criminal or security watch list and training snipers and other armed personnel secretly and clandestinely acquiring weapons to match for political purposes like Abacha and training them where Abacha trained his own killers, if it is true, it cannot augur well for the initiator, the government, and the people of Nigeria."

He also accused Jonathan of cleaving Nigeria apart - along the Christian-Muslim. According to him, Jonathan was favouring and promoting his Ijaw kin to the disadvantage of other Nigerians.

Obasanjo's letter was wellcelebrated. It was held up as a definitive and summary verdict on the administration of Jonathan. Obasanjo himself was hailed for his "courage and forthrightness", and for his audacity to look power in the eye and spit the truth. But all of that changed after the 2015 elections

owing to his overbearing deportment.

In 2018, just three years after President Buhari came to power, Obasanjo applied himself to accustomed enterprise. He dispatched an open letter to Buhari, accusing him of incompetence. According to Obasanjo: "The lice of poor performance in government poverty, insecurity, poor economic management, nepotism, gross dereliction of duty, condonation of misdeed – if not outright encouragement of it, lack of progress and hope for the future, lack of national cohesion and poor management of internal political dynamics and widening inequality – are very much with us today."

weak seams of north-south and In the build-up to the 2019 elections, Obasanjo fired a salvo. He accused Buhari of failing to address insecurity, of nepotism and of sundry ineptitudes. But Buhari earned the endorsement of Nigerians to serve a second time as president.

> Obasanjo said: "For over ten years, for four of which you have been the captain of the ship, Boko Haram has menacingly ravaged the land and in spite of government's claim of victory over Boko Haram, the potency

and the activities of Boko Haram, where they are active, remain undiminished, putting lie to government's claim. The main issue, if I may dare say, is poor management or mismanagement of diversity which, on the other hand, is one of our greatest and most important assets. As a result, the very onerous cloud is gathering. And the rain of destruction, violence, disaster, and disunity can only be the outcome."

In 2021, Obasanjo reprised himself in another letter to Buhari. But over time, his take or opinion on national matters has become tepid, vapid, and lacking in magnetism to hold public interest and to sway public opinion. His opinions have lost the power to cause mortal damage. And those who once eulogised him as the incarnation of courage, truth, and honesty are now his fiercest critics.

It seems that Obasanjo wrestles with anyone he fails to control and abominates anyone who resists his impingements.

Has the Ebora Owu been demystified? What is the worth of Obasanjo's endorsement? In the heat of the political liaisons in 2022, Obasanjo's hilltop mansion in Abeokuta, Ogun state, became

a cynosure of political pilgrimage as politicians fell over themselves to seek his endorsement of their bids. The rat race for Obasanjo's endorsement. At the time, supporters of Peter Obi, presidential candidate of the Labour Party, claimed that the former governor had the blessing of Obasanjo. Although Obasanjo concealed his intentions in pretensions of statesmanship, it was well-noised he was favourably disposed towards Peter Obi's candidature.

But the former president has cast aside the veil, and has declared support for Peter Obi, today, January 1, 2023.

The truth is Obasanjo's endorsement cannot take Peter Obi to the presidency. It cannot take him anywhere.

Obasanjo is a big masquerade. His place in Nigeria's political progression is undisputed. When iconic leaders are to be counted, Obasanjo will have a place. But in the cycle of life, there comes a time when the big masquerade will have to retire – when there is no one left in the crowd.





Full deregulation will curb fuel smuggling -Experts

Some oil and gas experts on Friday said full deregulation of the downstream sector of the petroleum industry was the only sustainable way to curb smuggling of petrol to neighbouring countries. The experts said in interview in Lagos against the backdrop of frequent smuggling of petroleum products outside the country.

Mr Ademola Adigun, an energy consultant, said market liberalisation remained the best option to reduce smuggling of petrol outside the country.

Adigun said competition was the most effective way to control market forces, adding that the best sanctions would not replace the need for price equalisation.

"The best sanctions will not replace the need for price equalisation. The key is still market liberalisation. "The best option is to allow market forces to control the price," he added.

Mr Robert Dickerman, the Executive Director, Pinnacle oil and gas Ltd., said ending subsidy payment to marketers would curb smuggling of petrol to other countries.

According to him, if government stops payment of subsidy, the problem will be solved immediately.

Ayodele Oni, Partner, Broomfield Law Practice, said crude oil theft (referred to as illegal bunkering) remained one of the biggest challenges facing the Nigerian oil and gas sector.

Oni said illegal bunkering in Nigeria was the largest globally by volume, with up to 20 per cent of Nigeria's oil output systematically stolen, illegally refined, sold or diverted.

According to him, "To curb this cankerworm, the federal government may need to adopt the following strategies: tighten security around the Niger Delta region, more scrutiny within export terminals in Nigeria.

"Government also needs to liaise with the local governments where the crude oil assets are located, adoption of modern technologies to monitor pipelines and track crude oil transportation and ultimately, developing Nigeria's refining capacity, amongst others." The expert said the adoption of these strategies would in no small measure help to curb the illegal bunkering of petrol to neighbouring countries.

Savings bonds: DMO announces 2023 first offer

he Debt Management Office (DMO) on Monday announced as its first bonds issuance for 2023, two Federal Government of Nigeria (FGN) Savings Bonds for subscription.

According to a statement by the DMO, one is a two-year FGN Savings Bond due in Jan. 11, 2025, at the interest rate of 9.600 per cent per annum.

The other is a three-year FGN Savings Bond due in Jan 11, 2026, at the interest rate of 10.600 per cent per annum.

The DMO said that the opening date would be Jan. 3, while the closing date would be Jan. 6, and

The Debt Management settlement date, Jan. 11, while Office (DMO) on Monday coupon payment dates would be announced as its first bonds April 11, July 11, Oct. 11 and Jan. 11.

"They are offered at N1,000 per unit subject to a minimum subscription of N5,000 and in multiples of N1,000 thereafter, subject to a maximum subscription of N50 million

"Interest is payable quaterly while bullet repayment (principal sum) is on maturity," it added.

The DMO said that FGN Savings Bonds qualified as securities in which trustees could invest under the Trustee Investment Act.

"They also qualify as government pension funds.



securities within the meaning of Company Income Tax Act (CITA) and Personal Income Tax Act (PITA) for tax exemption for pension funds.

"They are listed on the Nigerian Stock Exchange Limited and qualify as liquid asset for liquidity ratio calculation for banks," it said.

Consumers reject NAICOM'S directive on 3rd party insurance, call for reversal

he Insurance Consumers Association of Nigeria (INSCAN) has called on the National Insurance Commission (NAICOM) to reverse its directive on the increase of third Party Motor Insurance Premium in Nigeria.

This is contained in a letter signed by its National Coordinator, Chief Yemi Soladoye, and made available to newsmen on Sunday in Ibadan.

NAICOM had recently issued a policy directive on the increase of third party motor insurance premium in Nigeria by 200 per cent.

The INSCAN demanded the reversal of the directive, saying it amounted to deliberate breach of the fundamental Principle of Utmost Good Faith and other decent regulatory principles guiding Insurance practice.

"We hereby write with respect to your Circular No.: NAICOM /DPR/CIR.46/2022 dated Dec. 22, 2022, increasing the third party motor insurance premium in Nigeria by 200-400 per cent for different categories of motor vehicles.

"And by implication, giving only one

week notice to the insuring public of Nigeria to comply.

"We demand the reversal of the directive as it amounts to deliberate breach of the Fundamental Principle of Utmost Good Faith and other decent regulatory principles that guide insurance practice," it said.

The association said NAICOM failed to understand the full implications of its directive, saying those at the receiving end were insurance consumers who provided the accrued income to the entire Insurance Industry.

It said that NAICOM's reliance on the comparison of what was paid as premium in other parts of the world as basis for premium increment burden on Nigerians was tantamount to daylight robbery on consumers.

"Though, you threatened to sanction your Insurance Operators that fail to comply with your directive come Jan. 1, yet, the truth is that operators and NAICOM will benefit from the windfall accrued from the directive.

"The insurance consumers are, in the real sense of it, the ones being sanctioned," it said.



Nigeria's rising debt: The way forward





ost governments, multilateral organisations and the private sector across the world usually resort to borrowing to bridge revenue shortfalls and infrastructure financing.

It is, therefore, understandable that the Federal Government borrows to finance budget deficits, specific projects and refinance maturing debt obligations.

However, Nigeria's growing debt profile has been an object of discourse and concern for stakeholders in recent times. Indeed, the country's public debt has been under scrutiny for the rate of growth, debt service to revenue ratio and how it is utilised.

For instance, the total debt stock which stood at N7.50 trillion in 2012 had grown to N42.80 trillion as of June 30, 2022.

This has brought the Debt Management Office (DMO) under the spotlight, with the federal lawmakers recently accusing the agency of unrestrained borrowing.

However, the paucity of funds to implement Nigeria's budget over the years due to dwindling revenue has remained a major reason for the country's rising debt.

Data from the DMO as of September 30 showed Nigeria's total debt stock had risen to N44.06 trillion from N42.80 trillion in June, on the back of borrowings by the federal and state governments.

The figure, according to the DMO, was made up of total domestic and external debts of the Federal Government, all state governments and the Federal Capital Territory.

A breakdown of that figure showed that total domestic debt stock during the period stood at N26.92 trillion, while the total external debt stock stood at N17.15 trillion.

The DMO attributed the increase in the debt stock to "largely new borrowings by the Federal Government to part-finance the deficit in the 2022 Appropriation Act, as well as, new borrowings by subnationals.

However, speaking at the Capital Market Correspondents Association of Nigeria (CAMCAN) 2022 workshop recently, the Director-General, DMO, Ms Patience Oniha, stressed the need to operate an efficient tax administration for Nigeria to tackle its debt and revenue challenges.

Speaking on the theme: "Nigeria's Public Debt – Some Considerations," Oniha explained that such efficient tax administration must ensure greater compliance with remittances and shun all forms of evasion.

She stated that revenue challenge remained one of the most critical policy issues of the Federal Government, which was threatening the nation's debt sustainability.

Oniha noted that the outlook of both the local and international markets was already becoming tighter with rising interest rates.

She, therefore, stressed the need for the country to urgently moderate its new borrowing and ensure that public debt was sustainable by increasing its revenue base and rationalising expenditure.

Oniha said although the nation's total public debt to GDP of 23.06 per cent as as June, was still within Nigeria's self-imposed limit of 40 per cent and the World Bank/IMF recommended limit of 55 per cent for countries within Nigeria's peer group and 70 per cent for ECOWAS countries.

However, she argued that debt service to revenue was extremely high, an indication that urgent steps needed to be taken to boost the nation's revenue and enhance public debt sustainability.

"Nigeria's public debt stock has grown consistently over the past decades and even faster in recent years. Consequently, debt service has continued to grow.

"Nigeria's low revenue base compounded by dependence on crude oil resulted in budget deficits over the past decades. Efforts at increasing non-oil revenue are yielding positive results.

"Dependence on borrowing and low revenue base are now threatening debt sustainability. With a low debt to GDP ratio, Nigeria's debt service to revenue ratio would have been low if revenue was strong," she said.

According to her, most countries have placed emphasis on taxation as a principal source of funding for the government while the reverse is the case in Nigeria.

Besides taxation as a source of revenue generation, she stated that borrowings must be tied to projects that would generate commensurate revenues to service loans used to finance the projects.

Oniha also recommended that physical assets such as idle or under-utilised property could be redeveloped for commercialisation to generate revenue.

"Urgent actions are required to moderate the level of new borrowings and ensure that the public debt is sustainable through accelerating the growth in revenues, sale of government assets.

"The outlook shows that both the local and international markets are becoming tighter and interest rates are rising, thus priority should be less on borrowing and more on revenues from oil and non-oil sources," she said.

Corroborating her views, Prof. Uche

Uwaleke, president, Association of Capital Market Academics of Nigeria (ACMAN), said the country's huge debt burden would get worse if government revenues did not grow significantly next year.

Uwaleke urged government to take advantage of the current favourable international crude oil price by decisively tackling oil theft and ramping up production to meet OPEC's quota of about 1.8 million barrels per day.

"With respect to non-oil revenue, the implementation of the government's strategic revenue growth initiatives will go a long way in boosting revenue.

"This involves improvement in collection efficiency by revenue collection agencies such as the Federal Inland Revenue Service (FIRS) and the Customs.

"It also includes effectively taxing digital transactions and properly accounting for all proceeds against the backdrop of the recent controversy surrounding the unaccounted proceeds of stamp duty on electronic transfers," he added.

Uwaleke said the Federal Government should put in place measures using technology to ensure that collections by revenue-generating MDAs were properly monitored and duely remitted to the coffers of the government.

"These agencies should be given realistic targets and those unable to meet them without satisfactory explanation should have their Chief Executive Officers replaced.

"In the long run, more attention should be paid to diversifying revenue sources including privatisation of selected government enterprises and exports of commodities and finished products outside oil and gas," Uwaleke said.

Mr Ambrose Omordion, the Chief Operating Officer, InvestData Ltd., said

the case of Ghana should be a lesson for Nigerian leaders and economic managers.

"There is a saying that wise men learn from the mistakes or failures of others. What is happening to Ghana should be a lesson for Nigeria's leaders and economic managers.

"Despite the current situation of Ghana, its borrowing reflected on economic expansion and capacity before this ugly state.

"Nigeria's economy has contracted with huge borrowing instead of expanding with high cost of debt servicing to the detriment of capital projects and enabling business environment to drive the expected economic growth and progress.

"To reverse this trend of borrowing, the government should look inward and start with full and solid public private partnership, selling off abandoned assets, reduce high rate of taxation but widen tax net, drive economic diversification, provide security to attract foreign and local investments," Omordion said.

He also called on the government at all levels to reduce high cost of governance, restructure goverance system with real economic reforms and changes in 2023 and beyond.

Based on the above submissions, the nation's public debt stock will continue to grow if governments at all levels fail to change the narratives on ways to boost revenue base even as the country prepares for the 2023 general elections.

The major task before whoever emerges president come 2023 should be ways to increase revenue generation to reduce borrowing mainly for budget deficits.

Nigeria cannot continue to do things the same way and expect a different result, a stitch in time saves nine.

PEBEC stages play to address bureaucratic bottlenecks in businesses

he Presidential Enabling
Business Council (PEBEC)
on Sunday staged a play,
"Welcome To Easiland: The Future
Is Here", to enlighten Nigerians,
particularly entrepreneurs, on
how bureaucratic bottlenecks are
addressed by the government.

The play staged at the Landmark Event Centre, Lagos, portrays how businesses in "Easiland", likened to Nigeria, are sabotaged and ways to do things right.

Dr Jumoke Oduwole, Special Adviser to the President on Ease Of Doing Business, said that the play was also part of activities to mark the fifth anniversary of PEBEC.

According to her, PEBEC is a council that works on bureaucratic bottlenecks and legislative interventions for small and medium sized enterprises.

"As you saw from the play, those are realities that we have captured over the time. These are the realities that the team worked with.

"From the play, you saw some of the reforms that we have implemented. Sometimes, some errant officers will try to sabotage the reforms and we urge people to also lodge complaints.

"We have received a lot of compliments and we have also received a lot of complaints concerning the saboteurs within the system," she said.

Oduwole said the play was initially staged in Abuja during the Independence Day weekend after which people requested that the play be brought to Lagos.

"We had to squeeze it into the budget

so we could bring the play to Lagos over New Year's day just to celebrate the season and also to give hope and inspiration to Nigerian entrepreneurs.

"This is to enlighten them, as a lot of them don't know about the reforms. You saw the reforms at the Corporate Affairs Commission (CAC) and the Customs. A lot of things are going on that people don't know about," she said.

Oduwole said that the play was adopted as a form of enlightenment having realised that Nigerians love comedy and drama, adding that it was the perfect way to deliver the message.

She further encouraged the people to use report.gov.ng to lodge complaints if the reforms did not work, as feedbacks would be necessary to address bureaucratic bottlenecks.

According to her, the Ease of Doing Business is something that is here to stay and there is no need to know anyone in government to get the required services.

"People don't need to know Ministers or someone at the presidency. There is need to have an enabling environment where the legislative and regulatory bottlenecks are removed.

"Government parastatals' websites are working. You can use the technology to do your processes, your permits, nobody will tell you happy weekend or anything just to extort you.

"That is the message that we're preaching. And we want it to be entrenched in people's hearts. We want them to demand it as a right and we want government to deliver it as our responsibility, so that's what we're doing here today," she said.

Ghanaian experts advocate for science at UN Biodiversity Conference



Some Ghanaian experts who participated in the recent United Nations Biodiversity Conference in Montreal, Canada have called for the prioritisation of science and technology as the sure way to encourage socio–economic development.

Dr Justina Dugbazah who is the Coordinator of the African Union's High-Level Panel on Emerging Technologies says the world is advancing at a fast pace technologically, and Africa cannot afford to be left behind.

"When it comes to the harnessing of innovation and emerging technologies, this is actually what underpins emerging socio-economic development. If you look at all the development subsectors, be it agriculture, health, or education, harnessing innovations play a big role,"

she told Joy News in an interview.

"When you take agriculture, one can talk about drones that help identify the fertility of the soil, water level in the soil, and all that. And also one can look at biotechnology when it comes to crops.

"It's really important for African countries to be involved in negotiating such issues that are crucial to the growth of the countries," Dr Dugbazah added.

She observed there is a large gap that exists between research and policies across the continent that needs to be fixed

"There is the need to bridge the research, innovation, and policy gap. And this can only happen if we engage each other in the ecosystem," she noted.

The 15th meeting of the Conference of the Parties (COP15) to the Convention on Biological Diversity, deliberated on measures the world needs to take to protect the planet, and avoid situations where living things are destroyed in the environment due to human development activities.

It also served as the 10th meeting of the Conference of the Parties to the Cartagena Protocol on Biosafety (CP-MOP 10), and the Fourth meeting of the Conference of the Parties to the Nagoya Protocol (NP-MOP 4).

During the meeting from 7th to 19th December, governments from around the world came together to agree on a new set of goals to guide global action through 2030 to halt and reverse nature loss.

Dr Daniel Osei Ofosu who is a Research

Scientist at the Biotechnology and Nuclear Agricultural Research Institute (BNARI) of the Ghana Atomic Energy Commission (GAEC) observed that one major technology that can help protect the environment is biotechnology or genetically modified organisms (GMO) technology.

"Essentially, we are looking for innovative tools to help us protect the environment. We cannot continue to look at only the conventional tools that we all have. One of the key drivers of biodiversity loss is the cutting down of virgin forests and the need to expand our farming practices," he observed.

"Using tools like biotechnology, we are able to produce the best crops on very limited space that reduces the need for us to clear new areas.

"It also helps us to maintain the biodiversity that we have when we reduce the use of pesticides through biotechnology so nontarget organisms are not affected by the use of these pesticides. So innovative tools are necessary to help maintain the biodiversity that we have," he added.

Chairman of the governing board of Ghana's National Biosafety Authority, Prof. Charles Antwi-Boasiako, told a side event at the conference that Ghana is already adopting biotechnology and GMO tools to help improve agriculture and preserve the environment.

"Ghana approved genetically modified cowpea (which is resistant to some pests) for consumption in 2022. Next year, approval will be given for GM rice (which is nitrogen efficient, water-use efficient, and salt tolerant)," he said.

Appraising operational successes of the military in 2022

igeria has continued to contend with a number of internal security challenges ranging from insurgency and terrorism in the North East, banditry and kidnapping in North West and North Central, oil theft and pipeline vandalism in the Niger Delta and separatists agitation in South East and South West.

In spite of these security challenges, Nigeria has recorded remarkable improvement in security administration in 2022. The Armed Forces of Nigeria has remained steadfast in restringing peace and security across the country, and had deployed troops across the 36 states and Federal Capital Territory (FCT) to tackle all forms of security threats, in collaboration with other security agencies.

The strings of military operations across theatres of operations have lessened the various security threats and impacted positively on the lives of citizens and national development in general.

Although there are close to eleven thousand deaths recorded in 2022, most of the deaths have been due to military actions not from activities of non state actors.

In North Eastern Nigeria, the activities of Boko Haram and Islamic States West Africa Province (ISWAP) have been largely tamed.

The destruction caused by the 13-year insurgency in Borno, Yobe and Adamawa are being addressed, with millions of displaced persons returning home.

Since the beginning of 2022, the tempo of military operation in the North East under the Joint Task Force Operation Hadin Kai (OPHK) has escalated, leading to mass surrender of Boko Haram and ISWAP terrorists and their family members to troops in different fronts.

Available record revealed that more than 82,000 terrorists and their families have so far surrendered due to the intensity of military onslaught against them. More than 60,000 of those who surrendered did so in 2022, alongside their wives and children.

The onslaught also led to the capture of hundreds of terrorists across the region.

Today, about 900 arrested terrorists are awaiting prosecution, while thousands of the terrorists including their commanders, collaborators and logistics suppliers have been killed in land and air operations.

The successes recorded in the various operations conducted in the region by the military has

facilitated the return of peace and stability in most parts of the North East.

This is attested by the fact that most Internally Displaced Persons (IDPs) have returned to their ancestral homes while several farmlands hitherto inaccessible due to activities of terrorists, are now being cultivated.

According to the Theatre Command, OPHK, the operations also facilitated the rescue of 11 Chibok school girls who have been in captivity since 2014.

The first of the girls rescued, Hauwa Joseph, was intercepted along with her child at Ngazua in Bama on June 12, followed by Mary Dauda and her child rescued at Gava in Gwoza Local Government Area on June 14, while Ruth Bitrus and her child escaped from Ukuba Boko Haram terrorists camp in Sambisa and was rescued by troops in Bama on June 27.

On July 25, troops also rescued two Chibok girls named Kauna Luka and Hanatu Musa with their children at Aulari in Bama general area, while Aisha Grema who was pregnant was rescued with her four-year-old child in Bama on Aug. 21.

The seventh Chibok girl to be rescued was Falmata Lawal and her child on Aug. 30, in Bama general area. On Sept. 1, 2022, troops also rescued Asabe Ali and her child who escaped from a terrorists' camp in Gazuwa, Bama while the ninth Chibok girl, Jinkai Yama was rescued along with three children in Bama on Sep. 2.

Additionally, Yana Pogu and her four children became the 10th Chibok girl rescued by the military in 2022, while the eleventh was Rejoice Senki, who also had two children with her.

The eleven girls rescued in 2022 were listed on the roll of the abducted Chibok School girls as numbers 18, 46, 41, 38, 7, 11, 3, 12, 20, 19 and 70.

Similarly, the Nigerian Air Force (NAF) has had a very remarkable year in 2022, conducting a total of 1,398 sorties to counter insurgency and banditry across the country.

The Air Officer Commanding, Special Operations Command, AVM Abubakar Abdulkadir, said that NAF had flown over 1,950 hours during various operations between January and December in the North East and North West regions to tackle banditry and insurgency.

NAF intervention in the North West led to the elimination of many top terrorists and bandit commanders, while hundreds of kidnapped citizens were rescued.

There was also massive arrest of bandits' collaborators by troops of Operation Hadarin Daji in Katsina, Zamfara, Sokoto and Kaduna States.

Similarly, there have been several air bombardments by the air component of Operation Whirl Punch on many identified terrorists hideouts in Kaduna state with scores of terrorists including their top leaders neutralised.

As the intensity of military operations increased, the Defence Headquarters in November declared 19 terrorists wanted and placed N5 million bounty on each of them.

The wanted persons are notorious bandits and terrorists that have been terrorising Katsina, Sokoto and Zamfara states. Subsequent operational activities through land and air interdictions revealed that some of the wanted bandit kingpins were killed in Katsina and Zamfara.

In the North Central, troops of Operation Safe Haven also recorded a lot of successes in both kinetic and non-kinetic operations in Plateau and part of Kaduna states.

One of the high moment was on Oct. 29, when troops repelled an attack by Boko Haram and ISWAP terrorists on Wawa Military Cantonment in Borgu Local Government Area of Niger.

A coordinated land and air operations led to the killing of six of the terrorists and capture of 18 others while their equipment were captured and destroyed.

Also in 2022, troops of the Guards Brigade successfully apprehended about 60 hoodlums planning to cause security breach in the nation's capital on the eve on the Independence Day celebration.

However, there were some unfortunate ambushes in the FCT in which the lives of two officers and four soldiers were lost in July, just after the attack on Kuje Custodial Centre, which created panic in the territory.

The military and other security agencies were able to quickly bring the tensed situation under control and effectively countered the fake terror alerts issued by the United States and United Kingdom embassies in Nigeria.

To underscore the seriousness with which Nigeria views the security challenges, the National Security Council met three times in July to appraise the security situation and set target for the military and other security agencies. It's the first time in the history of the country that the council met three times in a month.

The effects have been monumental in terms of degrading insurgents, bandits and terrorists across the country.

In the Niger Delta region, the military joint task force, code-named Operation Delta Safe (OPDS), has during the year, destroyed 37 militant camps and over 1,883 illegal oil refining sites in the region.

According to the Commander, OPDS, Rear Adm. Aminu Hassan, 699 suspects were arrested in the effort to secure the operations of oil and gas companies in the Niger Delta as well as safeguard the people of the area.

The operations helped to save over N53 billion worth of crude oil, diesel, kerosene and petrol; destroyed not less than 37 militants and sea robbers camps and recovered 90 assorted illegal weapons and large caliber ammunition.

In the South East, the military has continued to confront the activities of the proscribed Indigenous People of Biafra and its militant wing, the Eastern Security Network, with remarkable successes.

On the whole, the armed forces of Nigeria has largely gained the upper hand against enemies of the state across the country in 2022.

It is instructive to note that attacks on troops' locations and ambush on their convoys have also reduced drastically in the course of the year.

These successes were propelled by enhanced joint operational planning and execution of the plans by all the three services, as well as improved synergy with other security agencies in the country.

There was also enhanced intelligence gathering and sharing as acknowledged by the Chief of Defence Intelligence, Maj.-Gen. Samuel Adebayo recently.

He said the agency has continued to carry out its mandates conscientiously with positive outcomes, adding that it prioritised technical and communication aspects of intelligence in support of armed forces operations and activities within and outside the country.

Adebayo said the DIA had also successfully dominated the threat environment with a combination of special intelligence operations and non-kinetic activities which had recorded degrees of successes and continued to deny the enemies of state, the cohesion and capabilities to operate.

"As we continue to review our activities, in 2023 the Agency intends to refocus its tactical and technical intelligence drive on all frontiers to sustain the gains.

"So far, the result across all theatres has been significantly rewarding," the defence intelligence chief said.
